

# Defend California's Oil Industry: Join CIPA Today

With California consuming 1.8 million barrels of oil daily, our clean, regulated production remains vital. Yet lawmakers continue to push policies aimed at eliminating domestic production — making the state more dependent on foreign oil from countries that don't share our political or environmental values.

### **Our 2025 Priorities:**

### **Confronting 3,200-foot Setbacks**

CIPA continues to oppose Senate Bill 1137, which imposes a 3,200-foot setback for oil operations, halts new well drilling and limits maintenance on existing wells. CIPA remains confident in securing a decisive legal resolution that allows California's oil producers to continue supplying the world's only climate-compliant oil, meeting the energy demands of Californians while reducing our dependency on more expensive foreign oil that drives up Californians' already sky-high gasoline prices. Two lawsuits, one from royalty and mineral owners and one from producers, have been filed against the state challenging SB 1137.

### **Opposing Harmful Industry Policies**

Assembly Bill 1243 and Senate Bill 684 are activist-driven proposals for unlimited legal damages against California's energy producers for wildfires, floods, earthquakes, and other natural disasters, regardless of fault. These bills are a dream for trial lawyers and a death sentence for local energy. The real cost will fall on Californians, who will face higher energy prices and increased reliance on foreign oil.

#### **Legislation to Support Domestic Production**

Senate Bill 13 will track countries exporting oil to California with human rights or environmental concerns. Senate Bill 767 fixes AB 1167 bonding requirements and extends the period state oil permits can be utilized by operators.

We are working with the Energy Commission and legislators to unleash Kern County production by making the Kern permitting process CEQA compliant and thus over the counter and not subject to litigation.

### **Recent CIPA Accomplishments**



### **Defeated Harmful Legislation**

CIPA halted legislation that would have severely damaged California's energy industry:

- Assembly Bill 3136: A proposal that would have given a big advantage to environmental justice groups.
- Assembly Bill 3155: A proposal that would have unjustly held oil and gas operators liable for health conditions.
- Senate Bill 1497: An overreaching measure that would have arbitrarily deemed oil companies liable for all climate impacts in California.



#### **Protected Producers Statewide**

CIPA led the effort to amend AB 1866 which originally required 25% of an operator's idle wells to be plugged each year. CIPA's advocacy prevented provisions that would have shut down multiple producers statewide.



### **Suspended CalGEM's Flawed Drone Program**

CIPA worked with CalGEM to end a methane drone surveillance initiative that delivered a 98% false-positive rate across 250 flights, saving operators from costly and unnecessary enforcement actions.



### Reinforced Regulatory Authority Over City and County of Los Angeles Amortization Ordinances

Working with the Native Oil Producers and Employees of California (NOPEC), CIPA defeated the City of Los Angeles' amortization ordinance, protecting operator rights and reinforcing state regulatory authority.



### Opposed LA City Council's Attempt to Halt Routine Oil Well Maintenance

When the Los Angeles City Council proposed banning acid-based oil well maintenance, CIPA raised legal, environmental, and policy concerns, opposing the politically motivated measure that jeopardized jobs, public safety, and energy reliability.



## Partnered with Interior and BLM to Reinforce Federal Authority over Federal Land Permitting

CIPA worked with the Department of the Interior and the Bureau of Land Management to have the federal government reassert its primacy over permitting on federal land.

**Annual Meeting**: CIPA's annual meeting is the largest gathering of oil and natural gas producers west of the Rockies. It offers a blend of networking opportunities and presentations on political, economic, regulatory, and other relevant issues.



**Board Meetings (Quarterly):** We hold one Board of Directors meeting in Sacramento, one in Bakersfield, one in the Los Angeles area, and one in conjunction with the Annual Meeting (location varies) each year.



**Monthly Meetings with CalGEM:** CIPA meets with the State Oil and Gas Supervisor and CalGEM staff every month to work on issues such as bonding, permitting, and emissions detection. CIPA members are welcome to attend in person or virtually.



**Monthly Lobby Days:** CIPA works with member companies to bring small groups of oil workers to Sacramento. We train them on CIPA issues and arrange face-to-face meetings with legislators, allowing each worker to share their story of how California's oil industry has benefited them, their families, and their communities.



**State Lobby Day:** CIPA members and staff deliver group presentations to legislators and have smaller, more intimate meetings in legislative offices. These sessions educate lawmakers about our issues and help dispel myths about our industry.



**Federal Lobby Days:** Our annual trip to Washington, DC, includes meetings and presentations with federal legislators and regulators, condensed into two highly effective days.



**Oil Symposium:** Each year, we bring together about 20 key legislators with 20 CIPA members in an intimate setting over two days. This creates a unique opportunity to educate and build relationships with legislators who make decisions impacting our industry.



**Fall Classic Golf Tournament:** Join us every October for a full day of networking and golf at the Bakersfield Country Club.



The Oil and Gas Regulatory Summit: This annual summit in Bakersfield brings together local, state, and federal regulators with operators to explore ways to improve the regulatory environment in California.





### **ENERGY ACADEMY PROGRAM**

The Energy Academy offers a six-week paid summer internship in oil & gas for recent high school graduates from inner-city areas. CIPA members provide on-the-job experience in various positions. To recruit, CIPA representatives make presentations in high schools, creating a new generation of energy ambassadors who understand the value of California oil. The program inspires a new pool of workers for member companies and provides powerful talking points when meeting with legislators in underserved communities.
